

PROFESSIONAL ADVANCED COURSE ON ARBITRATION

Arbitration is the binding process of alternative dispute resolution method to resolve suitable disputes. It is the process of resolving the disputes by a neutral arbitrator appointed by the parties on consensus or by other procedure given by arbitration law which results are based on the evidences submitted by the parties to the arbitral tribunal. Arbitration is the renowned method of dispute resolution used by the parties and the usage is developing tremendously. The commercial disputants are adopting this method into their original contract or through a separate arbitration agreement. The Right in Personam (Right against a person) disputes may be submitted to arbitration for its resolution. Out of this process the arbitral tribunal needs to attempt negotiation, mediation to settle the dispute amicably on agreed terms. If it is failed, then it would be decided upon reasoned arbitral award on the basis of evidences.

The conducting of arbitration proceedings is art of ability process by the neutral arbitrator. The fundamental ambit of arbitration depends upon the neutral arbitrator's knowledge and experience on arbitration and also upon the relevant subject area of the contract. The wisdom and fairness in the process plays determinative role in the arbitration process.

This professional advanced course of arbitration (40 hours) would provide knowledge and application of arbitration process in the Indian and International arbitration landscape. It is the comprehensive and intensive training program offers the participants about the facets of arbitration at a 360 degrees overview including procedure of arbitration (Ad-hoc/Institutional arbitration), writing of an arbitration agreement, checking of the validity of arbitration agreements, jurisdictional aspects of arbitration and drafting of a reasoned arbitral award. This course is designed to give participants a complete framework upon procedure of arbitration with the objective of practice ready. The course would be useful for who wants to become arbitrators in the different Indian arbitral institutions and even in Ad-hoc arbitration. This course also useful to lawyers in representing their clients in arbitration disputes and further useful to professionals in their related business of arbitration.
